(a) Grants.—Section 2021 of title 38, United States

5	"(b) Grants.—(1) In awarding grants for purposes
6	of conducting programs described in subsection (a), the
7	Secretary of Labor shall, to the maximum extent prac-
8	ticable, consider applications for fundable grants from en-
9	tities in all States.

11	ed a grant described in paragraph (1) as of the date of

13	Act of 2021, the Secretary of Labor shall, in coordination

15	in the State, organize and conduct an outreach and edu-
16	cation program to ensure communities are aware of the

19	(b) Contents of Biennial Report to Con-
20	GRESS.—Subsection (e) of section 2021 of such title, as
21	redesignated by subsection (a)(1), is amended—
22	(1) by inserting "(1)" before "Not less"; and
23	(2) by striking the second sentence and insert-
24	ing the following:

"(2) The Secretary of Labor shall include in each re-
port submitted under paragraph (1) the following:
"(A) An evaluation of services furnished to vet-
erans under this section.
"(B) An analysis of the information collected
under subsection (c).
"(C) An identification of—
"(i) the total number of applications for
grants under this section that the Secretary re-
ceived during the fiscal year preceding the date
on which the report is submitted; and
"(ii) the number of such applications that
were denied.
"(D) With respect to each State in which no
entity was awarded a grant under this section dur-
ing the fiscal year preceding the date on which the
report is submitted—
"(i) an identification of the top five rea-
sons why entities that applied for such a grant
were not awarded the grant; and
"(ii) information regarding the specific cri-
teria used to score the applications and an ex-
planation of if, how, or why such criteria dif-
fered from the previous fiscal year.".
